► **PRELIMINARY INFORMATION:**

Contest judges will not have any affiliation with contestants in any way. A maximum of 3 judges per weekly competition will be chosen. Judges will be allowed to return for judging in as many weekly competitions as desired as long as space is available. The competition will run for 18 weeks every Friday beginning on December 2, 2011 through April 13, 2012 (excluding January 27 & March 9) with Finals on April 20, 2012. Competition will begin at 9pm. There is no limit to the number of contestants per team allowed. There is a limit of at least 2 minutes per contestant/team allowed for music/dance but no more than 5 minutes. Contestant/team is required to request song of choice on Entry Form; however chosen song may not include any explicit, vulgar or offensive language. Any winners of a weekly competition will not be allowed to participate in any future competitions of Magic City Casino's Bailar Miami until Finals on April 20, 2012. A maximum of 15 teams will be allowed to compete in the weekly competitions. Selected participants will be contacted via phone or email for confirmation of participation. If there is an overwhelming response, dance performance may be possibly held on another occasion.

► **ELIGIBILITY:**

Open only to legal residents of Florida who are 18 years of age or older at the time of entry.

► **HOW TO ENTER:**

Persons wishing to enter Magic City Casino's Bailar Miami competition must submit an Official Entry Form from the Magic City Casino website (www.magiccitycasino.com). The weekly prize amounts are as follows: \$200 for 1st place, \$100 for 2nd place and \$50 for 3rd place. The sum shall be awarded to the entire team, not for each individual in a team. Any distributions shall be exercised in the sole discretion of the individual comprising the entry.
